## **Reconstitution of S&P BSE Indices- Updates**

India, Mumbai, Tuesday December 01, 2015: This is in continuation with the rebalance announcement issued on November 20, 2015, CCL International Ltd (Exchange Ticker- 531900) will be dropped from S&P BSE 500 effective December 02, 2015 on account of suspension due to consolidation, instead of December 21, 2015. The subsequent add Uflex Ltd (Exchange ticker-500148) will not be added to S&P BSE 500 effective December 21, 2015.
