# Methodology Change - S&P BSE SENSEX

**India, Mumbai, Tuesday, February 16, 2016**: Asia Index Private Limited announced today that it will make the following change to the index methodology for the S&P BSE SENSEX.

Effective with the **June 2016 rebalance**, the following changes are being applied to the index:

Change	Current Methodology	New Methodology
Eligible Universe	All common equities listed at BSE Ltd. (excluding companies classified in Z group, listed mutual funds, companies suspended on the last day of the month prior to review date, companies objected by the Surveillance Department of BSE Ltd. and those that are traded under a permitted category and SME category) are considered eligible.	S&P BSE SENSEX will be derived from S&P BSE 100
