Clarification to the Index Methodology of S&P BSE Greenex

India, Mumbai, Monday, June 06, 2016 - Asia Index Private Limited today announced clarification to the index methodology of S&P BSE Greenex.

For GHG emission numbers (C), stocks which are in between the scale of 50-100 within the sector are assigned a point of 1000. This ensures that stocks with relatively lower GHG emission numbers in the universe have higher probability of index inclusion. In addition, for sectors where there is only one stock, point 25 is assigned for GHG emission numbers (C), average three-month float market capitalization (M) and average three-month value traded (T).
