# Modification to the Methodology of S&P BSE Indices

**MUMBAI, MAY 18, 2017:** Asia Index Private Limited announces change to the methodology of S&P BSE SENSEX, S&P BSE 200 and S&P BSE 500 indices regarding the treatment of multiple share classes for index inclusion. The following change will be implemented with the June 2017 rebalancing.
