Result performance review

Quarter results overview

- Pranavaditya Spinning Mills reported quarterly results for December 2014. The company's operating income witnessed a decline of 20.9% on a year on year (YoY) basis during the quarter. The expenses too were down by 21.7% YoY during the same period.
- The company reported an operating profit of Rs 3.2 m during the quarter as compared to profit of Rs 2.2 m during the same quarter of the previous year. Consequently the operating margins improved to 2.1% during the quarter.
- Depreciation was higher by 16.7%YoY and interest charges remained unchanged for the December 2014 quarter.
- The company's net profit margin improved to 0.5% during the quarter.




Current valuation


At the current price of Rs 27, the company's stock trades at 38.5 times its trailing twelve month earnings.




Quarterly financial trend charts
