

Quarterly result review - March 2016

- ✓ For the fourth quarter ended March 2016, VAS Infra Limited reported a 64.6% YoY decline in revenues to ₹147.5 million in Q4′FY16 from ₹416.2 million in Q4′FY15.
- ✓ On a QoQ basis, revenues increased 36.8% from ₹107.8 million in Q3'FY16.
- ✓ EBITDA margins were at negative during the quarter compared to 61.1% in the year ago quarter.
- ✓ The company reported a net loss of ₹ (105.9) million during the
 quarter compared to a net loss of ₹ (3.45) million in the prior
 year quarter.


