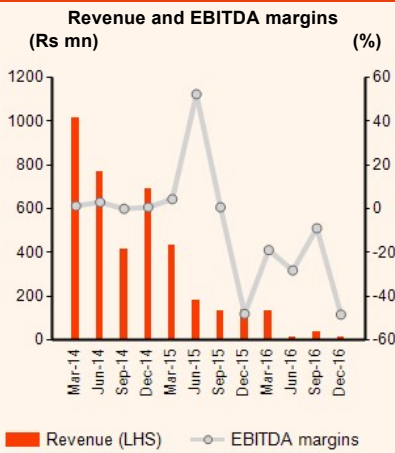

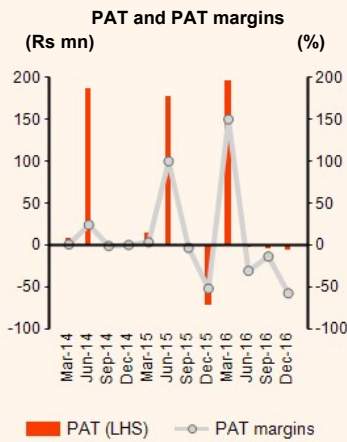
### FINANCIAL UPDATE

- Net loss stood at Rs 5 mn in Q3FY17 vis-à-vis net loss of Rs 71 mn in Q3FY16.

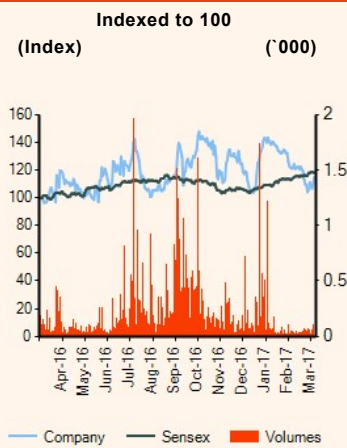
### Financial Performance Trends

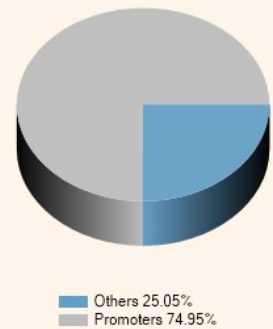


### Share Price Chart
