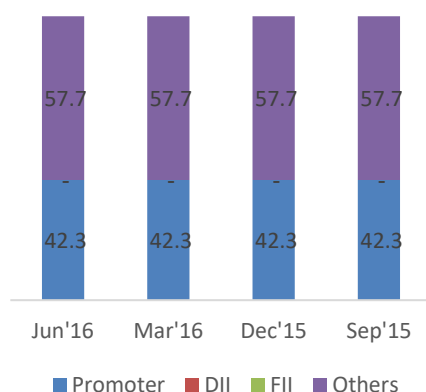

Financial Performance

In the quarter ended 30 June 2016, the total income of the company decreased by 8.5% to Rs.1.2 mn from Rs.1.3 mn reported in the same period of the previous year. The EBITDA margin reduced to 53.8% v/s 59.2% reported for the quarter ended 30 June 2015. The Company reported net profit of Rs.0.4 mn v/s Rs.0.5 mn for the quarter ended 30 June 2015.
