



Financial Performance

In the quarter ended 31 March 2017, the total income increased to Rs. 1.4 mn from Rs. 1.2 mn. The Company reported net profit of Rs.0.8 mn as compared to Rs.0.7 mn for the same period of the previous year.

On a sequential basis, total income of the company increased to Rs. 1.4 mn. The company's profit increased to Rs.0.8 mn from Rs.0.7 mn over the quarter ended 31 December 2016.
