



Quarter results overview

Result performance review

- Panasonic Energy announced its results for the quarter ended March 2013. At Rs 470 m, the company's net sales grew by 4% on a year on year (YoY) basis.
- The operating expenditure for the quarter was up by 3% YoY. The gross profit margins during the quarter stood at 1.9% as compared to 0.6% during the corresponding quarter in the previous year.
- The depreciation expenses for the quarter increased by 5% YoY, while interest costs were up by 50% YoY.
- The company reported net profit of Rs 4.4 m (up 46.7% YoY) for the quarter, up 46.7% YoY.
- The company's board has recommended dividend of Rs 2 per share for the financial year ending March 2013.






At the current price of Rs 44, the company's stock is trading at 13.8 times its trailing twelve month earnings.




Quarterly financial trend charts
