

# Panasonic Energy (I) Co. Ltd.

### Quarter results overview

#### Result performance review

- Panasonic Energy (India) reported quarterly results for Sept 2014. The company's operating income witnessed healthy growth of 10.7% on a year on year (YoY) basis during the quarter. However, the expenses were up by a proportionately lower rate of 4.9% YoY during the same period.
- As a result of strong growth in income, operating profit increased by 112.3% YoY. Simultaneously, operating margin expanded to 10.5% YoY during the quarter from 5.5% in the same quarter of the previous year.
- Other income increased 340% YoY. Depreciation & interest was lower by 27% & 33.3 YoY for the Sept 2014 quarter.
- The company's net profit increased by 154% YoY during the quarter as a result of strong operating performance and other income.


