
#### **Company Info:**

The Company has recorded revenues of ₹ 9.97 Crores during the current quarter as against ₹ 12.93 Crores for the corresponding quarter last year. EBITDA margins for the current quarter increased to 7.22% in Mar quarter this year as compared to 3.17% in the same quarter previous year. The Profit after Tax (PAT) for the current quarter stood at ₹ 0.56 Crores.






**Quarterly Income Growth**
