## **Quarterly result review – March 2016**

Trade Wing Limited revenues witnessed 28.1% growth and reached ₹59.8 million in Q1'17 compared to ₹46.7 million in Q1'16, while on QoQ basis the company's revenue grew by 18.2%.

EBITDA margin for the quarter stood at 10.8%, down from 16.7% in the same period of the earlier year.

The company reported a net loss of ₹0.3 million in Q1'17, compared with a profit of ₹0.9 million and ₹8.1 million in the periods Q1'16 and Q4'16 respectively.


