

The Company was formerly known as Kamanwala Industries Limited and changed its name to Kamanwala Housing Construction Limited in November 2006. Kamanwala Housing Construction Limited was incorporated in 1984 and is based in Mumbai, India.

The Company has recorded revenues of ₹ 29.2 Crores during the current quarter as against ₹ 26.87 Crores for the corresponding quarter last year. EBITDA margins for the current quarter increased to 15.24% in Dec quarter this year as compared to 1.19% in the same quarter previous year. The Profit after Tax (PAT) for the current quarter stood at ₹ 1.37 Crores.


