# Quarterly result review - March 2017

Winro Commercial (India) Ltd. reported a total income of ₹14.9 million in Q4′FY17 compared to a negative ₹-1.17 million in Q4′FY16. On a sequential basis, total income increased 32.09% from ₹11.28 million in Q3′FY17.

EBITDA came in at a negative ₹3.12 million compared to a negative ₹13.35 million in the prior year quarter and a positive ₹8.1 million in the preceding quarter.

The company reported a net loss of ₹26.24 million during the quarter compared to a net profit of ₹7.22 million in the prior year quarter.


