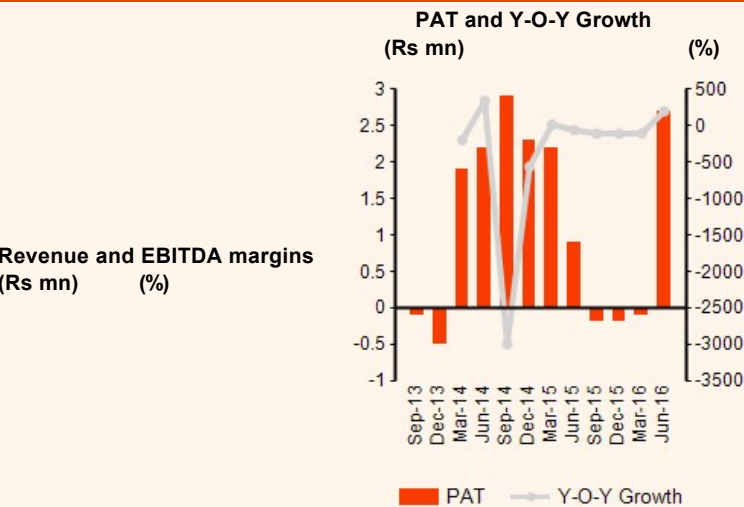

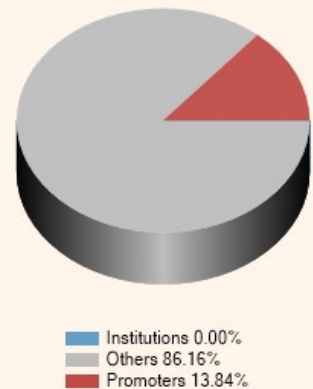
### Share Price Chart
