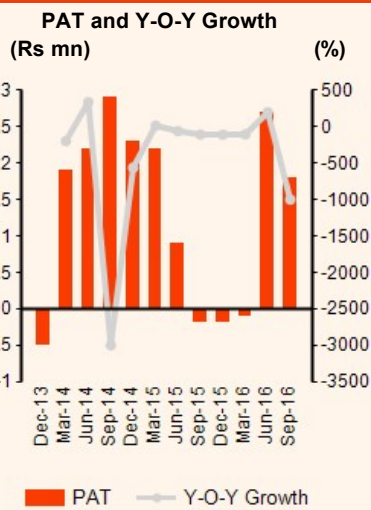

(Rs mn) (%)

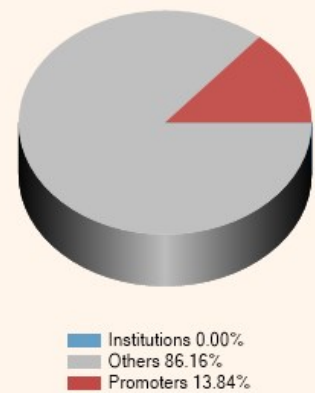
## Share Price Chart
