



Quarterly Review - Dec 16:

The Company has recorded revenues of \mathbf{E} 146.42 Crores during the current quarter as against \mathbf{E} 123.82 Crores for the corresponding quarter last year. EBITDA margins for the current quarter decreased to 8.78% in Dec quarter this year as compared to 18.57% in the same quarter previous year. The Profit after Tax (PAT) for the current quarter stood at \mathbf{E} -3.17 Crores.


