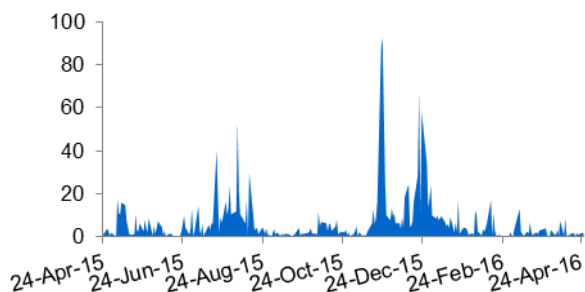

### BSE Volumes Trend - Average = 6.75 Thousand

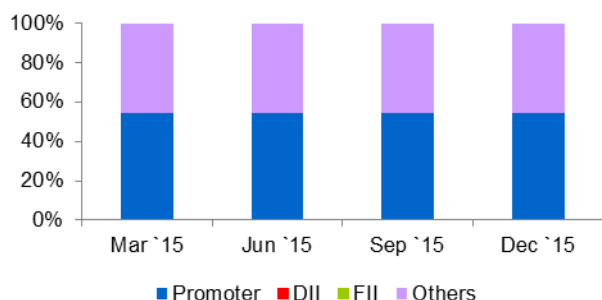


### Relative Returns

### Result analysis

Vippy Spinpro Limited's (VSL) Q3FY16 total income decreased by 10.67 % y-o-y and to Rs. 20.28 crore. The company reported an EBITDA of Rs.1.67 crore (down 23.24% y-o-y) in Q3FY16. The company reported a net profit of Rs.0.79 crore in Q3FY16 as compared to net loss of Rs.1.01 crore in Q3FY15.

During 9MFY16, the company reported 9.35% y-o-y fall in net sales to Rs.66.06 crore while during this period EBITDA of Rs.4.97 crore. VSL's net profit stood at Rs.1.97 crore during 9MFY16 as compared to net profit of Rs.2.24 crore during 9MFY15.

VSL is trading at 4.57 times 12 months trailing EPS.
