

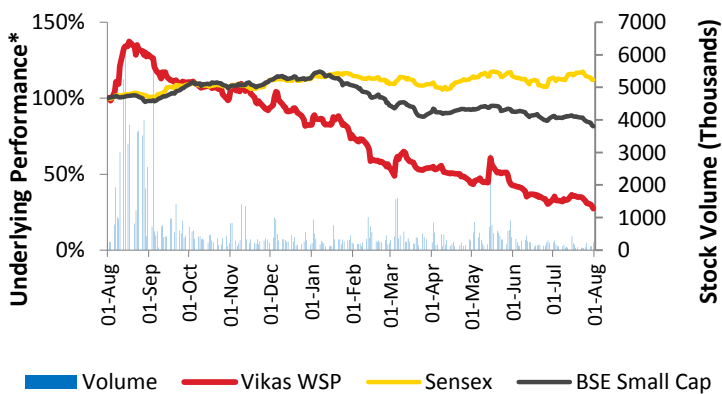

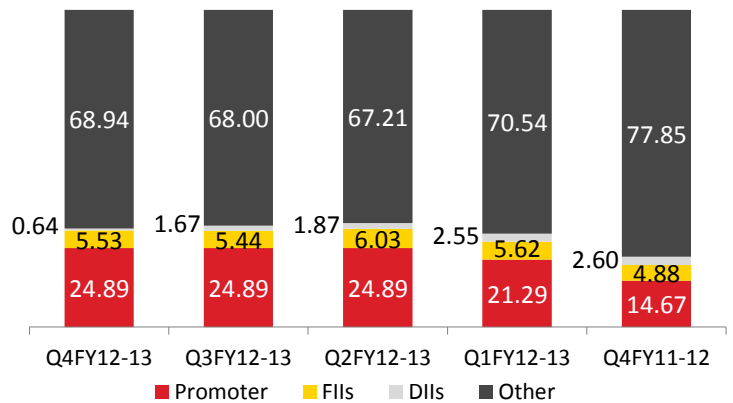

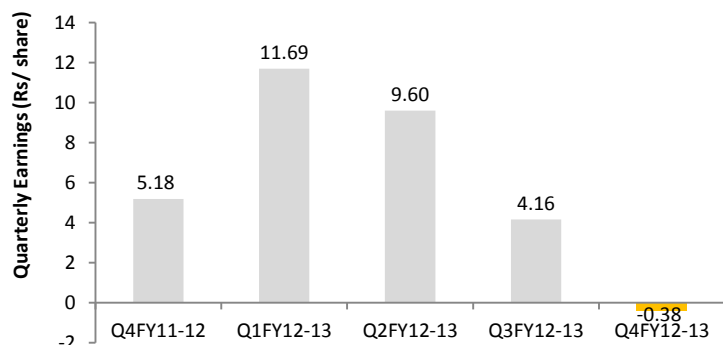
The company has recorded a gross sale of ₹347.97 crore during the current period ended 31-Mar '13 as against ₹510.30 crore for the corresponding quarter last year. EBITDA margins have decreased to 3.91% in Q4FY13 compared to 24.19% in Q4FY12. The Profit after Tax (PAT) of ₹-5.17 crore is reported this quarter (Q4FY13) as compared to ₹71.16 crore in Q4FY12.

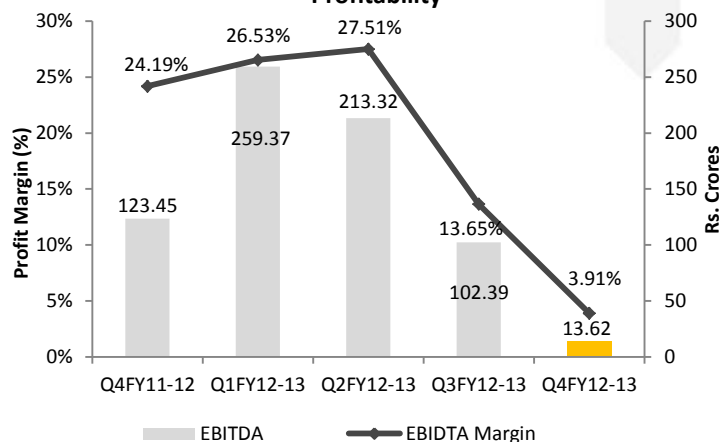

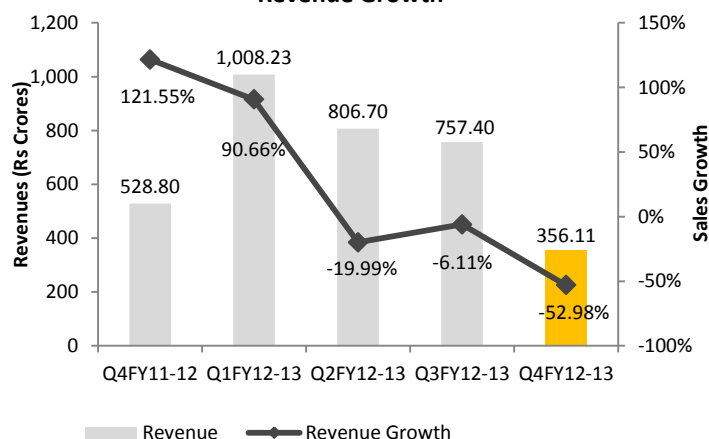
**Quarterly EPS History**



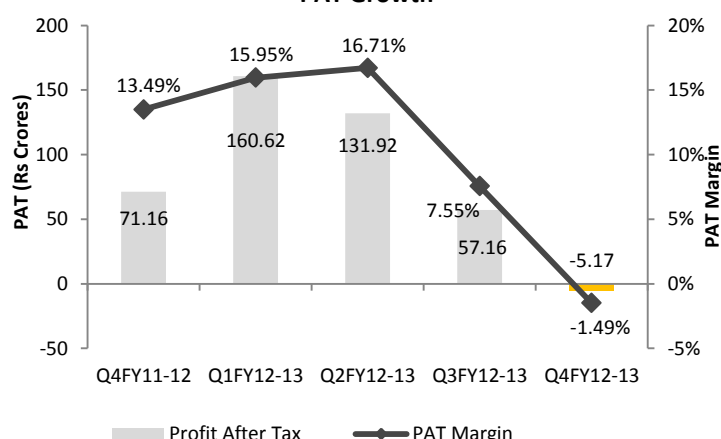
**Profitability**
