

### **Company Info:**

Ocean Agro (India) Limited produces and sells agro chemicals in India. It offers special LDPE valve type polymer bags, polybutadiene rubber films, co-extruded films, and other packaging materials; agro inputs, such as organic fertilizers, bio fertilizers, organic pesticides, organic fungicides, bio fungicides, viricides, and organic plant growth hormones; and irrigation equipment comprising drip and sprinkler systems. The Company sells its products through a network of dealers. In 1995, the Company set up a drip/sprinkler irrigation system in Baroda for which it received subsidies from the Gujarat government. It has also set up a solar photovoltaic pumping system for agricultural purposes with financial assistance from IREDA. Ocean Agro (India) Limited was incorporated in 1990 and is headquartered in Baroda.


