

Company Info:

Ocean Agro (India) Limited produces and sells agro chemicals in India. It offers special LDPE valve type polymer bags, polybutadiene rubber films, co-extruded films, and other packaging materials; agro inputs, such as organic fertilizers, bio fertilizers, organic pesticides, organic fungicides, bio fungicides, viricides, and organic plant growth hormones; and irrigation equipment comprising drip and sprinkler systems. The Company sells its products through a network of dealers. In 1995, the Company set up a drip/sprinkler irrigation system in Baroda for which it received subsidies from the Gujarat government. It has also set up a solar photovoltaic pumping system for agricultural purposes with financial assistance from IREDA. Ocean Agro (India) Limited was incorporated in 1990 and is headquartered in Baroda.

The Company has recorded revenues of \gtrless 3.66 Crores during the current quarter as against \gtrless 4.05 Crores for the corresponding quarter last year. EBITDA margins for the current quarter decreased to -5.46% in Mar quarter this year as compared to 25.43% in the same quarter previous year. The Profit after Tax (PAT) for the current quarter stood at \gtrless -0.68 Crores.


