Quarter results overview

Result performance review

- Dhanlaxmi Fabrics reported quarterly results for June 2014. The company's operating income witnessed a healthy growth of 37.6% on a year on year (YoY) basis during the quarter. Its expenditure was up at a relatively lower rate of 35.2% YoY during the same period.


