

The Company's products include maize starch powder; unigel, a pregelatinised starch; liquid glucose; utexlose, a thin boiling starch; white dextrin, a hydrolyzed starch; unisol, an oxidized starches; dextrose monohydrates; dextrose anhydrous; dextrose syrups; maltose corn syrups; caramel, a natural food color; maize germs; maize germ oil cakes; maize gluten, a high protein substance; maize refined oils; oxidized starches; cationic starches; esterified starches; and amphoteric starches. Its products are primarily used in food, paper, textile, pharmaceutical, and confectionary industries. The Company was founded in 1973 and is based in Mumbai, India.
