Quarterly result review – March 2016

Systematix Corporate Services Ltd. reported a drop of 98.4% YoY in revenues to ₹1.9 million in Q4′FY16 from ₹115.0 million in Q3′FY16. On a sequential basis revenue increased 220.7% from ₹0.6.

EBITDA was at negative $\stackrel{<}{_{\sim}}$ 1.1 million compared to a EBITDA of $\stackrel{<}{_{\sim}}$ 20.2 million in the Q4'FY15.

The company reported a net loss of ₹ 2.2 million during the quarter compared to a profit of ₹13.3 million in the Q4′FY15. QoQ basis it improved from a loss of ₹3.4 in Q3′16.






