# **Quarterly result review – June 2016**

Systematix Corporate Services Limited revenues witnessed 43.3% growth and reached ₹0.43 million in Q1'17 compared to ₹0.30 million in Q1'16, while on QoQ basis the company's revenue declined by 76.9%.

EBITDA for the quarter stood at  $\mathbb{E}(2.81)$  million compared with  $\mathbb{E}(5.04)$  million in the same period of the earlier year.

The company reported a net loss of ₹3.75 million in Q1'17, compared with a loss of ₹5.84 million and ₹2.18 million in the periods Q1'16 and Q4'16 respectively.


