

# **Quarterly result review - September 2016**

Systematix Corporate Services Limited revenues increased 4593.3% to ₹21.1 million in Q2'17 compared to ₹0.5 million in Q2'16, while on QoQ basis the company's revenue rose 4811.6% from ₹0.4 million in Q1'17.

EBITDA for the quarter stood at ₹16.2 million compared with ₹(2.9) million in the same period of the earlier year.

The company reported a net profit of ₹15.4 million in Q2'17, compared with a loss of ₹3.8 million and ₹3.7 million in periods Q2'16 and Q1'17 respectively.


