

Quarterly result review – December 2016

Systematix Corporate Services Limited revenues witnessed 5.2% growth and reached ₹ 0.61 million in Q3'17 compared to ₹ 0.58 million in Q3'16, while on QoQ basis the company's revenue declined by 97.1%.

EBITDA for the quarter stood at ₹ (2.65) million compared with ₹ (2.51) million in the same period of the earlier year.

The company reported a net loss of ₹ 3.23 million in Q3'17, compared with a loss of ₹ 3.41 million and a profit of ₹ 15.44 million in the periods Q3'16 and Q2'17 respectively.


