
# **Quarterly result review - March 2017**

Systematix Corporate Services Limited reported a 76.34% YoY increase in total income to ₹3.28 million in Q4′FY17 from ₹1.86 million in Q4′FY16. On a sequential basis, total income increased 437.70% from ₹0.61 million in Q3′FY17.

EBITDA came in at a negative ₹1.77 million compared to a negative ₹1.12 million in the prior year quarter and a negative ₹2.65 million in the preceding quarter.

The company reported a net loss of ₹1.61 million during the quarter compared to a net loss of ₹2.18 million in the prior year quarter.


