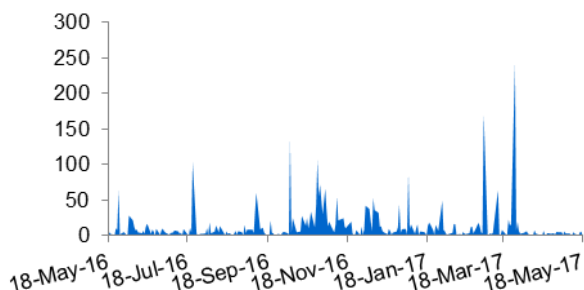

BSE Volumes Trend - Average = 13.11 Thousand

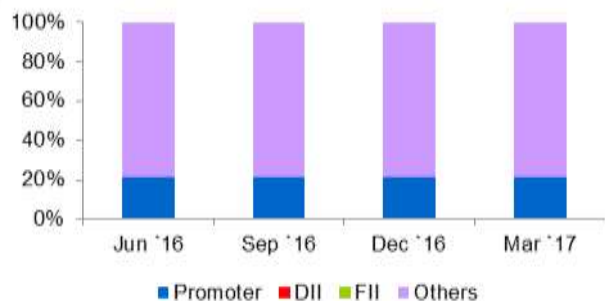


Relative Returns

Result analysis

Odyssey Technologies Limited's (OTL) Q3FY17 total income increased by 4.66% y-o-y and to Rs.3.64 crore. The company reported an EBITDA of Rs.1.26 crore in Q3FY17 (down 18.54 %). The company reported a net profit of Rs.0.81 crore in Q3FY17 as compared to net profit of Rs.1.03 crore in Q3FY16.

During 9MFY17, the company reported 8.81% y-o-y rise in net sales to Rs.8.40 crore while during this period EBITDA increased by 1.34% to Rs.3.02 crore. OTL's net profit stood at Rs.1.78 crore during 9MFY17 as compared to net profit of Rs.1.80 crore during 9MFY16.

OTL is trading at 18.11 times 12 months trailing EPS.
