Odyssey Technologies Limited's (OTL) Q2FY18 total income improved by 22.65% y-o-y and to Rs.3.54 crore. The company reported an EBITDA of Rs.1.17 crore in Q2FY18 (up 19.61%). The company reported a net profit of Rs.0.61 crore in Q2FY18 as compared to net profit of Rs.0.68 crore in Q2FY17.
