



Quarter results overview

Result performance review

- Asian Oilfield announced its results for the quarter ended March 2013. At Rs 203 m, the company's net sales increased 6% on a year on year (YoY) basis.
- In response to increased net sales, the company's expenditure declined by 11% YoY. As a result it reported gross profit of Rs 33 m for the quarter as compared to gross loss during the same quarter of previous year. Its gross profit margin stood 16% for the quarter.
- Depreciation increased by 3% YoY while interest expenses grew by 21% YoY.
- At the bottom line, the company reported profit after tax of Rs 20 m for the quarter as compared to net loss of Rs 8.7 m during same quarter of previous year.






The company's stock trades at Rs 17, its trailing twelve months EPS is negative. Hence the PE ratio is not meaningful.




Quarterly financial trend charts
