# **Quarter results overview**

# Result performance review

- Asian Oilfield net sales increased by 327.8% on a year on year (YoY) basis during the December 2013 quarter. Its expenses, however, increased at a slower rate of 221.1% YoY during the same period.
- The company reported an operating profit of Rs 111.8 m during the quarter as compared to operating loss of Rs 0.9 m during the same quarter of the previous year.
- Depreciation and interest charges were higher by 73.8% YoY and 170.1% YoY respectively for the December 2013 quarter.
- The company reported net profit of Rs 59.9 m as compared to a net loss of Rs 22.4 m during the same quarter of the previous year. Its net margin stood 13.1% during the quarter.




#### **Current valuation**






# **Quarterly financial trend charts**
