
Company Info:

The company has recorded revenues of Rs 5.64 Crores during the current quarter as against Rs 5.42 Crores for the corresponding quarter last year. EBITDA margins for the current quarter decreased to 17.91% in Dec quarter this year as compared to 27.31% in the same quarter previous year. The Profit after Tax (PAT) for current quarter stood at Rs 0.54 Crores.










Quarterly Income Growth
