# Quarterly result review – June 2016 Virat Industries Ltd reported a 10.9% YoY decline in total income to

₹57.01 million in Q1'FY17 from ₹63.97 million in Q1'FY16. On a sequential basis, total income increased 0.7% from ₹56.62 million in Q4'FY16.

EBITDA came in at ₹ 13.11 million compared to ₹ 15.19 million in the prior year quarter and ₹ 12.1 million in the preceding quarter.

The company reported a net profit of  $\gtrless$  6.6 million or  $\gtrless$  1.35 per share during the quarter compared to a net profit of  $\gtrless$  7.95 million or  $\gtrless$  1.62 per share in the prior year quarter.








# EBITDA margin (%)
