# **Quarterly result review - September 2016**

Vijay Solvex Limited reported a 1.8% YoY increase in total income to ₹1453.82 million in Q2′FY17 from ₹1428.52 million in Q2′FY16. On a sequential basis, total income decreased 17.2% from ₹1755.60 million in Q1′FY17.

EBITDA came in at ₹ 32.87 million compared to ₹ 35.30 million in the prior year quarter and ₹ 45.03 million in the preceding quarter.

The company reported a net profit of ₹18.86 million during the quarter compared to a net profit of ₹7.37 million in the prior year quarter.


