# Quarterly result review - June 2017

Vijay Solvex Limited reported a 10.89% YoY decline in total income to ₹1564.44 million in Q1'FY18 from ₹1755.6 million in Q1'FY17. On a sequential basis, total income increased 0.97% from ₹1549.34 million in Q4'FY17.

EBITDA came in at ₹26.31 million compared to ₹45.03 million in the prior year quarter and ₹63.13 million in the preceding quarter.

The company reported a net profit of ₹11.32 million or ₹3.8 per share during the quarter compared to a net profit of ₹13.69 million or ₹4.28 per share in the prior year quarter.


