





Shri Krishna Devcon Limited's (SKDL) Q1 FY17, total income decreased to Rs.2.49 crore as compared to Rs.3.46 crore in Q1 FY17. The company's EBITDA stood at Rs.0.36 crore in Q1 FY17. The company reported a net profit of Rs.0.04 crore in Q1 FY17 as compared to net profit of Rs.1.37 crore in Q1 FY16.
