Result performance review

Quarter results overview

- Inani Marbles' operating income grew by 14.3% on a year on year (YoY) basis during the quarter. Its expenses increased by 21% YoY during the same period.
- A faster rise in expenses led to a 30% YoY fall in operating profits during the quarter. Consequently, operating margins were impacted, falling to 8.1% during the quarter (13.1% in March 2013).
- Other income declined by 33% YoY. Interest charges were down by 24.7% YoY for the March 2014 quarter.
- The company's net profits declined by 33.3% YoY on account of poor operating performance and a decline in other income.
- The company's board declared final dividend of Rs. 1 per share for FY14.






At the current price of Rs 143, the company's stock trades at 8.5 times its trailing twelve month earnings.




Quarterly financial trend charts
