Quarter results overview

Result performance review

- Inani Marbles reported quarterly results for Sept 2014. The operating income witnessed a growth of 18.2% on a year on year (YoY) basis during the quarter.
- Its expenditure grew at a relatively faster pace of 25.9% YoY during the quarter under review. As a result, operating margin fell to 14% in Sept 2014 quarter which led to decline in operating profit by 13.9% YoY in the period.
- Other income increased from Rs 0.1 m in Sept 2013 quarter to Rs 0.7 m in Sept 2014 quarter.
- Depreciation charges remained negligible, while interest charges declined by 18.6% YoY for the Sept 2014 quarter. Effective tax rate went down to 32.4% in Sept 2014 quarter.
- The company's net profit decreased by 2.8% YoY during the quarter.


