

The Company offers absorbable sutures, such as natural and synthetic sutures; and non-absorbable sutures comprising needles for cardiovascular surgery, monofilament polyamide atraumatic needle suture combinations, monofilament stainless steel, and temporary pacemaker electrodes. It also provides female urinary incontinency sets, titanium hemostatic clips for cardiovascular surgery, non-absorbable synthetic knotted surgical meshes, disposable aortic punch for cardiovascular anastomosis, disposable skin stapler maniplers, and cardiovascular vessel knifes for cardiovascular surgery. The Company was founded in 1995 and is based in Thane, India.


