

# Quarterly result review - June 2016

VAS Infrastructure Limited revenues declined 56.3% and reached ₹79.8 million in Q1'17 compared with ₹182.9 million in Q1'16, while on QoQ basis the company's revenue declined by 50.7%.

EBITDA for the quarter stood at ₹(8.02) million compared with ₹(21.01) million in the same period of the earlier year.

The company reported a net loss of ₹56.6 million in Q1'17, compared with a loss of ₹23.3 million and ₹105.9 million in periods Q1'16 and Q4'16 respectively.


