

Quarterly result review – June 2017

VAS INFRASTRUCTURE LTD. reported a 38.66% YoY decline in total income to ₹49 million in Q1′FY18 from ₹79.88 million in Q1′FY17. On a sequential basis, total income increased 50.91% from ₹32.47 million in Q4′FY17.

EBITDA came in at a positive ₹5.61 million compared to a negative ₹8.02 million in the prior year quarter and a negative ₹2.58 million in the preceding quarter.

The company reported a net loss of ₹31.59 million during the quarter compared to a net loss of ₹56.65 million in the prior year quarter.


