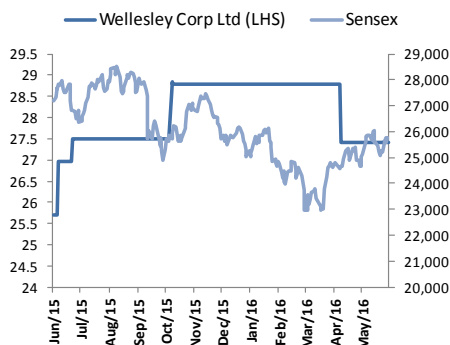

**Quarterly result review – December 2015**

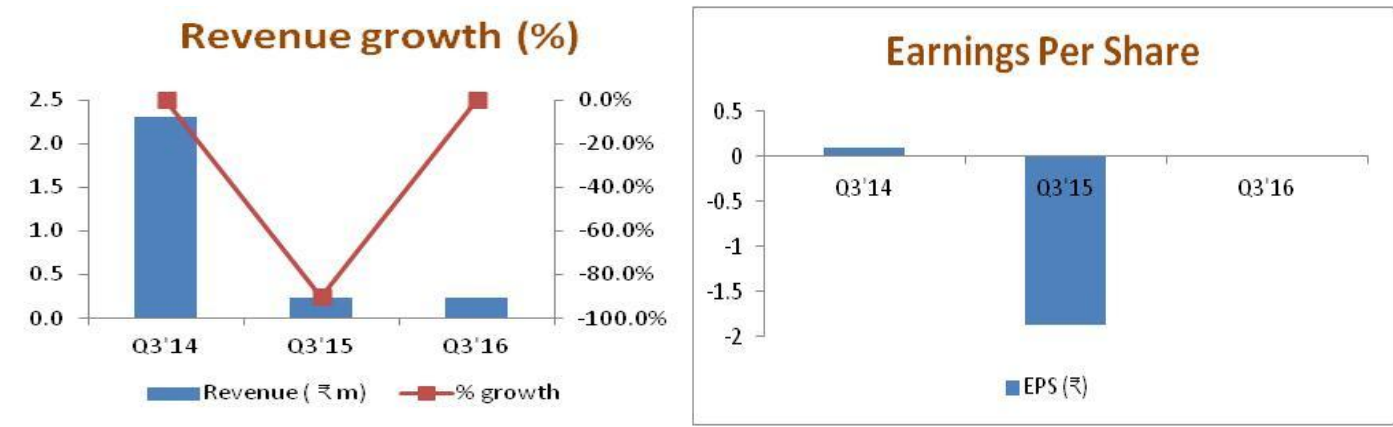
- ✓ For the quarter ended 31 December 2015, the total income of the company flat at ₹0.2mn when compare it to corresponding quarter of the previous year.
- ✓ On a q-o-q basis, the total income increased from ₹0.1mn to ₹0.2mn for the quarter ended 31 December 2015.
- ✓ EBITDA for the Q3'16 were at ₹0.02mn up from ₹(18.1)mn in Q3'15. EBITDA margins were at 8.7% as compare to negative in Q3'15.
- ✓ Net profit for the third quarter of FY16, was at ₹0.02mn from ₹(25.4)mn on a y-o-y basis.
