

Quarterly result review - March 2017

Wellesley Corporation Limited reported 36.8% YoY increase in total income to ₹ 0.26 million in Q4′FY17 from ₹ 0.19 million in Q4′FY16. On a sequential basis, total income decreased 18.8% from ₹ 0.32 million in Q3′FY17.

EBITDA for the quarter remained negative at $\mathbf{\xi}$ (0.28) million compared to $\mathbf{\xi}$ (0.19) million in the year earlier quarter.


