

Quarterly result review - September 2016

Siel Financial Services Limited revenues grew 1000% to ₹0.09 million in Q2'17 from ₹(0.01) million in Q2'16, while on QoQ basis the company's revenue fell 98.7% from ₹6.9 million in Q1'17.

EBITDA for the quarter continued to remain in the negative territory of $\mathbb{Z}(0.23)$ million compared with $\mathbb{Z}(0.25)$ million in the same period of the earlier year.

The company reported a net loss of ₹0.20 million in Q2'17, compared with a loss of ₹0.25 million and a profit of ₹3.70 million in periods Q2'16 and Q1'17 respectively.


