## **Quarterly result review – March 2017**

Siel Financial Services Limited reported a 82.86% YoY decline in total income to ₹0.06 million in Q4′FY17 from ₹0.35 million in Q4′FY16. On a sequential basis, total income declined 53.85% from ₹0.13 million in Q3′FY17.

EBITDA came in at a negative ₹0.09 million compared to a positive ₹0.28 million in the prior year quarter.

The company reported a net loss of ₹0.42 million during the quarter compared to a net profit of ₹0.28 million in the prior year quarter.






# Total Income growth (%)




### **EBITDA margin (%)**
