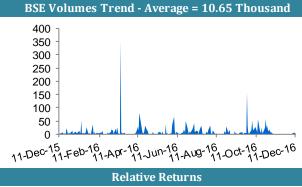


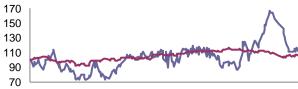

### **Result analysis**

Baba Arts Ltd. (BAL), total income increased by 40.87% y-o-y to Rs.0.49 crore in Q1FY17 as compare to total income of Rs.0.35 Crore in Q1FY16. However, the EBITDA of (BAL) remained same to negative Rs.0.14 crore in Q1FY17. The company reported a net profit increased to 187.50% (Y-o-Y) to Rs.0.25 Crore in Q1FY17 as compared to net profit of Rs.0.09 Crore in Q1FY16.

BAL is trading at 100.27 times its 12 months trailing EPS.
