

### **Quarterly result review – March 2016**

Saven Technologies limited reported a revenue of ₹23.2 million in Q4′FY16 as compared to ₹20.35 million same quarter a year ago. On sequential basis revenue dropped by 0.4% from ₹23.27 million in Q3′FY16.

EBITDA came in at ₹ 5.11 million in the Q4′FY15, compared to ₹5.38 million same quarter year ago.

The company reported a net profit of ₹ 0.81 million during the quarter compared to ₹3.61 million in Q4′FY15. On a sequential basis it dropped from ₹ 5.6 million in Q3′FY16.




