Quarterly result review - March 2017

Saven Technologies Limited reported a 1.50% YoY increase in total income to ₹26.38 million in Q4′FY17 from ₹25.99 million in Q4′FY16. On a sequential basis, total income declined 8.59% from ₹28.86 million in Q3′FY17.

EBITDA came in at ₹3.5 million compared to ₹5.11 million in the prior year quarter and ₹8.42 million in the preceding quarter.

The company reported a net profit of ₹2.44 million during the quarter compared to a net profit of ₹0.81 million in the prior year quarter.


